

## Attachment 1: Tuition Fee Refund Eligibility

### Domestic Students

HE & VET (Diploma and above)	Withdraw <b>before census date</b>	Full refund of paid tuition fees
HE & VET (Diploma and above)	Withdraw <b>after census date but before next census date</b>	No refund for current study period refund for future study period if prepaid
VET (Certificate I–IV)	Withdraw <b>before course start date</b>	Full refund
VET (Certificate I–IV)	Withdraw <b>after start date but before last refund date (4 weeks after unit start date)</b>	Refund of tuition fees; materials fee refund at teaching department’s discretion, dependent on if materials have been provided
VET (Certificate I–IV)	Withdraw <b>after last refund date</b>	No refund

## Partial Refunds – International Onshore Students

Enrolment cancelled for non-payment of tuition fees	<p>Refund of partial payment made minus non-refundable deposit (as per Letter of Offer)</p> <p>Application fees paid not refunded</p>
<p>Australian Government authorities refuse to grant a student visa; or</p> <p>the student visa is not granted in time for the student to start the course; or</p> <p>a student withdraws their visa application with the Australian Government before the commencement of the Course; or</p> <p>the student does not submit a visa application; or</p> <p>the student fails to provide additional information to support their application, as requested by the University (e.g. statement of purpose or certified documents); or</p> <p>where the University withdraws an offer based on incorrect, false or incomplete information provided by the student or their agent</p>	Refund pre-paid fees minus lesser of: 5% of the total amount of pre-paid fees received before the default day; or \$500
