

Remission of Debt and Post Census Amendment of Enrolment Procedure

Section 1 - Summary

(1) This Procedure outlines the administration of the remission of HECS-HELP and VET Student Loans, the re-credit of FEE-HELP and VET FEE-HELP loans, the refund of upfront fees, and the post-census amendment of enrolment.

 - a. All students and former students;
 - b. Staff who administer enrolments and remissions.

Section 6 - Procedures

Part A - Summary of Roles and Responsibilities

Roles	Responsibilities
VUHQ	Accept and date-stamp application and documents forward to Student Financials.
Coordinator Student Financials (CSF)	Assess application and take appropriate action.
Review Officer	Review application as requested.
Student Advocacy	Can lodge a remission application on a student's behalf in circumstances where the student has sought support with the remission process from an Advocate.

Part B - Procedures

Lodgment of Applications

(16) Completed application forms, along with supporting original or certified documentation attached must be lodged as per the Remission of Debt and Post-Census Amendment of Enrolment Policy via:

- a. VUHQ, where they will be stamped and forwarded to the Coordinator Student Financials (CSF); or
- b. Registered/certified post to the Coordinator Student Financials, Victoria University, PO Box 14428, Melbourne, Vic, 8001.

(17) The CSF will assess the application and will either:

- a. Decline the application because it falls outside the guidelines; or
- b. Remit the student's debt (HECS-HELP); or
- c. Re-credit the student's debt (FEE-HELP, VET FEE-HELP, SSAF payment when paid up front and VET Student Loans);
- d. Refund tuition where paid up front.

Assessment of Application

(18) Applications for post-census remission of debt in exceptional circumstances will be considered by the CSF as per legislative requirements and <u>Assessment of Compassionate</u>, <u>Compelling or Special Circumstances</u>.

(19) Students can find more detail in <u>Assessment of Compassionate</u>, <u>Compelling or Special Circumstances</u>.

Timeframe for Making Decisions

- (20) The CSF must consider the student's application as soon as practicable, but no later than 14 days after receipt.
- (21) In the case of a student with a Low Completion Rate requesting a review of Special Circumstances, the application will, where possible, be considered prior to the student's next enrolled census date. If the outcome to the

application for Special Circumstances is not able to be finalised prior to the next census date, the student will be ineligible for a Commonwealth Supported Place/FEE-HELP. The student may decide to withdraw from that study period and await the outcome of the application.

Notification of Decision

- (22) The CSF must notify the student of the decision. The notification must include:
 - a. The basis for the decision; and,
 - b. The right to a review of the decision if the student is unsatisfied with the outcome.
- (23) Where a decision results in the remitting, re-crediting or refunding of a student's balance, the CSF will:
 - a. Notify the student of the decision in writing; and
 - b. Notify the Enrolment team to request that the approved decision is reflected in the student's enrolment record;
 - c. Arrange appropriate documentation and processes to refund or remit where appropriate; and
 - d. Forward documents to Student Records for filing in accordance with the Records Management Policy.
- (24) Any refund will be made from the ledger account(s) originally credited with the funds.
- (25) The Manager, Student Lifecycle Operations and Reporting or nominated staff member will:
 - a. Advise the relevant government department(s) of the remission.

Review of Decisions

- (26) Students have a right to a review of the decision not to remit, re-credit or refund fees.
- (27) The Review Officer must occupy a different and more senior position to the officer who made the original decision, and must not have been part of the original decision. The Review Officer is the Director, Student Administration, or delegate.
- (28) The review application must be made within 28 days from the decision notification. The student must state why they are seeking a review.
- (29) The Director, Student Administration, or delegate must acknowledge receipt of the review request.
- (30) The Director, Student Administration, or delegate may:
 - a. Confirm the decision;
 - b. Vary the decision; or
 - c. Make a new decision.
- (31) The Director, Student Administration or delegate will notify the student in writing of the reviewed decision, and the reason for reaching this decision with 45 days of receiving the application for review.
- (32) The Director, Student Administration or delegate will also notify students of:
 - a. Their right to appeal to the Administrative Appeals Tribunal (the AAT) if the student is unsatisfied with the outcome; and
 - b. The details of the nearest AAT registry.
- (33) If the decision is reviewed by the AAT, the Director, Student Administration or delegate must supply the AAT with

all application documents via courier or Express Post within five days of notification.

Requested Post-Census Enrolment Amendments by Colleges or Students

- (34) The University may only make amendments to a HE enrolment after the census date when:
 - a. Exceptional circumstances apply; or
 - b. An administrative error has occurred.
- (35) A College representative may forward a request for post-census amendment to the Manager Enrolments and Student Financials for consideration.
- (36) The request must include the circumstances of the amendment, and may include:
 - a. A requested enrolment update was not processed in a timely manner;
 - b. The unit of study is not being delivered in this study period/year.
- (37) Each request is considered on its own merits and a fee determined by the <u>Fees Policy</u> is charged for each amendment made to contribute to administrative costs.
 - a. Amendments made as the result of data entry error do not attract a fee.

Glossary Terms and Definitions

"HECS-HELP" - A government loan scheme for students studying in a Commonwealth Supported place.

"FEE-HELP" - A government loan scheme for students studying in a full-fee place.

"VET FEE-HELP" - A former government loan scheme for students studying in a VET program. This has now been superseded by VET Student Loans.

"VET Student Loans" - VET Student Loans offer income contingent loan support to eligible students studying certain diploma level and above vocational education and training qualifications.

"SA-HELP" - Government loan scheme to cover student services and amenities fee. Not eligible for remission.

"OS-HELP" - Financial Assistance to eligible CSP to undertake part of their course of study overseas. Not eligible for remission.

"Student Services and Amenities Fees (SSAF)" - A fee charged to support services and amenities to onshore students subject to Government legislation e.g. sport, recreation, counselling and childcare.

"VET" - Vocational Education and Training.
